IV. COMMUNITY ANNOUNCEMENTS

- FEMA representative, Bob Covelli, and Audrey Penny from Bucks County Emergency Services presented Wes Foraker with a plaque recognizing the Borough's status as a Class 8 community in the NFIP's CRS (Community Ratings System) program. This rating acknowledges communities that go above the minimum requirements to participate in the NFIP CRS program. Paula Johnson and the community were also recognized for their work to achieve this rating. Pennsylvania has the most NFIP communities (2400) in the country and nationally only 5% of communities go above the minimum requirements and join the CRS. Effective 4/1/22 Yardley Borough is 1 of 27 participating CRS communities in PA and is 1 of 13 Class 8 communities. Class 8 provides 10% discount on flood insurance policies purchased through the program.
